Pursuant to state and federal law, the Secretary of State, a County Clerk or any other registration agent, will not release the provided protected information. A person who unlawfully copies, conveys or uses information from a certificate of registration is guilty of a fourth degree felony. Additionally, voter files provided to the public shall not include email addresses.

If you are registering to vote in person or are currently registered to vote in New Mexico, no identification need be shown or attached to complete this registration. Pursuant to the HELP AMERICA VOTE ACT, if you are submitting this form yourself by mail (not through a Voter Registration Agent)

REQUIREMENTS

and it is the first time you have registered in the state of New Mexico, you must submit a COPY of a photo ID issued by a government or educational institution or a COPY of a current utility bill, bank statement, paycheck or other government document that shows your name and address in this county. If you submit this information now you will avoid being required to show documentary identification at the polling place on Election Day.
