Page 12 section D to be replaced with the following:

Intake and Receiving: Consists of 11 holding areas which allow the separation of detainees by classification and sex. There is a complete screening area which screens an average of 40 detainees in a daily, twenty-four (24) hour, period. **Mandatory pregnancy and diabetes testing is a component of the intake screening process.** There is a mandatory complete medical assessment within 14 days of admission that shall include mandatory tuberculosis testing.

Page 23 (Staffing Levels) to be replaced with the following:

The following are suggested minimal staffing levels necessary to provide daily medical care coverage in the Adult Facility and the Offeror is encouraged to provide a suggested staff plan.

- *One Medical Director; Board Certified Physician on-site ten (10) hours per week and on-call twenty-four (24) hours per day/seven (7) days a week for medical emergencies and support. Will consider a Nurse Practitioner.
- ** One Nurse Practitioner on-site thirty-two (32) hours per week and on-call twenty-four (24) hours day/ seven (7) days a week for medical emergencies.
- *One Health Services Administrator Registered Nurse (RN) full-time coverage, minimum 40 hours per week. On call twenty-four (24) hours per day/seven (7) days a week for medical emergencies and support.
 - a. *One Director of Nursing Registered Nurse (RN); full-time coverage, minimum 40 hours per week. And on call twenty-four (24) hours per day/seven (7) days a week for medical emergencies and support.
- *Required enough Registered Nurses (RN); to accommodate a (Monday- Friday) "24/7/365" full-time coverage 40 hours a week and on call twenty-four (24) hours per day/seven (7) days a week for medical emergencies and support.
- Two Clerical Staff full-time coverage 40 hours a week
- Intake Screening Staffing to adequately cover 24/7 coverage to all shifts/times,

including lunches/breaks

8 Health Care Staff - 24/7 - Shift 1 (3 employees) @ ADC*

Shift 2 (3 employees) @ ADC*

Shift 3 (3 employees) @ ADC*

- Pharmaceutical Services to adequately accommodate established protocols of the National Commission on Correctional Health Care (NCCHC)
- o One Rise Grant funded position for a Mental Health Provider thirty-two (32) hours a week.
- One Rise Grand funded position for a Mental Health Administrative Assistant, forty (40) hours a week.

Page 28 / 29 to be replaced with the following:

Mental Healthcare:

- One Certified Mental Health Practitioner; (C.M.H.P.) *Twenty-six (26) Hours. Per week, As needed when needed – on call 24/7
- One Certified Mental Health Professional (MSW) *40 Hrs. Per Week on call 24/7 As needed when needed – on call 24/7
- One Mental Healthcare Professional (LCSW) *40 Hrs. Per Week on call 24/7 As needed when needed – on call 24/7
- Licensed Master Level Social Worker (MSW)
- Licensed Clinical Social Worker (LCSW)_
- *At no time will the Adult facility be without the standard minimum 26 hours per week of a Certified Mental Healthcare Professional or 40 hours of the Mental Healthcare Professional (MSW) & (LCSW)
