- ✓ Be a registered voter in San Juan County, NM
- ✓ Not be convicted of a felony
- ✓ Reside in the county or district
- ✓ Be a citizen of the United States
- ✓ Be 18 years of age

# Nominating Petitions

## For Candidates:

---

- Top portion of the petition must be completed before circulation, preferably typed.
- Get extra signatures
- Signer must be:
  1. a registered voter and live in district
  2. have same political party

## Signing the petition:

---

- Must be registered voter in the district
- Must be in same political party
- Sign only one (1) petition for same office
- Top portion of petition should be completed before signing

# Sample Nominating Petition

I also declare that I have not signed, and will not sign, any nominating petition for more persons than the number of candidates necessary to fill such office at the next ensuing general election.

**March 12, 2024** - Filing Day



**March 19, 2024** – Filing Day for Write-In Candidates



**April 2, 2024** – Last day for candidates to withdraw



**June 4, 2024** – Primary Election Day
