### **Board of Finance**

 Consideration of Approval of Resolution No. 23-24-39, Authorizing Investment of Monies in the Local Short-Term Investment Fund

Carol Taulbee, Treasurer, indicated that each year, the San Juan County Commission must authorize the County Treasurer and the Chief Deputy Treasurer to invest County monies in the local short-term investment fund, pursuant to Section 6-10-10.1, N.M.S.A., 1978, which is managed by the New Mexico State Treasurer. The Resolution authorizes Carol Taulbee, County Treasurer and Bryan Myers, Chief Deputy Treasurer to deposit or withdraw monies in the local short-term investment fund. A motion was made by Chairman Pro-Tem Fortner, seconded by Commissioner Lanier to approve Resolution No. 23-24-39, Authorizing Investment of Monies in the Local Short-Term Investment Fund. Upon voice vote this motion passed unanimously.

A motion was made by Commissioner Lanier, seconded by Chairman Pro-Tem Fortner to adjourn the Board of Finance Meeting, and call to order the Regular Meeting. Upon voice vote, the motion passed unanimously.

### Approval of Agenda

Mike Stark, County Manager, stated that there were no changes to the agenda. A motion was made by Commissioner Lanier, seconded by Chairman Pro-Tem Fortner to approve the agenda as presented. Upon voice vote the motion passed unanimously.

A motion was made by Commissioner Lanier, seconded by Chairman Pro-Tem Fortner to approve the Consent Agenda. Upon voice vote the motion passed unanimously.

#### **New Business**

## 1. Consideration of Approval of Resolution No. 23-24-44, Acceptance of the FY23 Annual Comprehensive Financial Report (ACFR) – Completed by Pattillo Brown and Hill, LLP

Kim Martin, Chief Financial Officer, explained that Section 2.2.2.10M(4) NMAC (2023 New Mexico State Audit Rule) requires that the FY23 ACFR be presented by the IPA (Pattillo, Brown and Hill, LLP) to a quorum of the County Commission at a meeting held in accordance with the Open Meetings Act. Furthermore, the New Mexico Department of Finance and Administration requires the Commission sign a resolution accepting the audit. Ms. Martin introduced Chris Garner, Partner with Pattillo, Brown and Hill, LLP. Mr. Garner reported a successful compliance audit with a clean opinion. There were no difficulties encountered during the audit and no corrected misstatements. The County has received the Government Finance Officers Association (GFOA) Certificate of Achievement for Excellence in Financial Reporting for 17 consecutive years. A motion was made by Commissioner Lanier, seconded by Chairman Pro-Tem Fortner to approve Resolution No. 23-24-44, Acceptance of the FY23 Annual Comprehensive Financial Report (ACFR) – Complete by Pattillo Brown and Hill, LLP. Upon voice vote the motion passed unanimously.

### 2. Consideration of Agreement to Transfer Totah Subdivision Wastewater and Water System Improvements Project from San Juan County to the City of Farmington

Mike Stark, County Manager, stated that at the November 9, 2021 Commission meeting, interim spending plan for the first tranche of American Rescue Act Plan (ARPA) funding was approved, which included funding for the Totah Subdivision Water and Wastewater system project. A total of \$10,000,000 in APRA funding was approved for the Totah project and a \$1,000,000 grant was received from the Office of Natural Resources Trustee Gold King Mine settlement, bringing total project investment to \$11,000,000. Given the proximity of the subdivision to the City of Farmington's water and sewer infrastructure, Staff met with city officials to lay out a preliminary agreement for design involvement, incentives for homeowner connectivity, assignment of construction warranties, transfer of assets, and ultimate operating responsibilities. On October 12, 2022, the City conducted a Public Information Meeting to inform homeowners of incentives offered, which include in-city sewer rates, waiver of water/sewer connection fees, and the abandonment of septic systems will be offset by the construction contract. The agreement to transfer the project formalizes the previously discussed verbal commitments and will be presented to the Farmington City Council on January 9th. A motion was made by Commissioner Lanier, seconded by Chairman Pro-Tem Fortner to approve the Agreement to Transfer Totah Subdivision Wastewater and Water System Improvements Project from San Juan County to the City of Farmington. Upon voice vote the motion passed unanimously.

### 3. Consideration of Open Meetings Resolution No. 23-24-40

Ellen Wayne, Deputy County Attorney, stated The Open Meetings Act requires that a public body determine annually what notice for a public meeting is reasonable when applied to that body. Ms. Wayne indicated that the Resolution includes that standing meetings will be the 1st and 3rd Tuesday of every month at 4:00 p.m. Upon review of the resolution, a motion was made by Commissioner Todacheene, seconded by Commissioner Lanier to approve Open Meetings

Resolution No. 23-24-40. Upon voice vote the motion passed unanimously

### 4. <u>Consideration of Resolution No. 23-24-42, Cancelling and Rescheduling Certain</u> <u>Meetings in Calendar Year 2024</u>

Mike Stark, County Manager, requested the approval of Resolution No. 23-24-42 to cancel and reschedule the following Regular Commission Meetings:
