2. Project Overview - Carlyn Rodahl

A. Site:

The site is currently vacant. There will be extensive dirtwork required to build up the pad. Expansive soils will be removed and replaced. All utilities will be extended to the site from adjacent properties.

New Building:

The building is approximately 9,000 square feet enclosed with some covered entry and patio areas under roof. Construction is a steel post and beam system with steel bar joist/metal deck roof structure. Exterior steel stud curtain wall is nonbearing. Finishes include CMU veneer, metal prefinished board and batten siding, standing seam metal roof. The interior is basically office area, classrooms and a commercial quality kitchen.

HVAC:

The office areas utilize combo horizontal furnaces mounted in the plenum space while the classrooms and kitchen areas will use roof mounted combo units. The kitchen will have an exhaust hood with makeup air unit. A mini-splits units is used in the IT room.

Electrical:

A new 600 amp services will be brought in from the east side underground and distributed to three (3) sub panels. Standard power and lighting, some low voltage access control system.
